- (2) Need for a unified, single source, Parking Access Revenue Control System to operate all CCPA parking decks and lots.
- (3) Ultimately a single spare parts inventory for all five (5) CCPA parking facilities
- (4) Single maintenance service provider for all Parking Authority Parking Access Revenue Control Systems operated by the CCPA
- (5) Interchangeable spare parts for all Parking Access Revenue Control System installed in CCPA parking facilities
- (6) Interchangeable coin vaults and dollar bill acceptor and stackers for all CCPA parking facilities pay stations

- (7) Single software system for the production of monthly parking and maintenance of the access card issuance and data base for all parking facilities operated and owned by the CCPA
- (8) Parking Authority staff can be trained to operate a single Parking Access Revenue Control System more efficiently and effectively to increase productivity.
- (9) Staff is better able to generate management, operations, parking utilization, billing and financial reports.
- (10) Hamilton system utilizes prepaid parking validation token notes for special events.
