WHEREAS, the Parking Authority of the City of Camden ("Authority") is a public corporation established by declaration of necessity by the legislature in the Parking Authorities Law, N.J.S.A. 40:11A-1 et seq. for the public purpose to promote the public safety convenience welfare and the necessity in the public interest for the provision of public parking; and

WHEREAS, the Authority is vested with all powers necessary or convenient to carry out and effectuate its corporate purpose of the construction, provision or operation of off-street parking projects within its area of operation; and

**WHEREAS**, pursuant to the Parking Authorities Law, <u>N.J.S.A</u>. 40:11A-6(3) the Authority is authorized to plan, design, construct, reconstruct, enlarge, improve, manage, maintain, repair, operate and use such parking project or projects as in the opinion of the authority will provide an effective and satisfactory method for promoting the purposes of the authority; and

WHEREAS, the Authority has undertaken the planning of a mixed use development commonly referred to as the Block N Transit Village Parking Deck Project (the "Project") which includes construction of a structured parking deck and appurtenant facilities on Block 175 on the official tax map of the City of Camden; and

WHEREAS, by Resolution No. R2014-06:50 adopted on June 23, 2014, the Commissioners of the Authority resolved to authorize the planning of a mixed use development commonly referred to as the Block N Transit Village Parking Deck Project; and

WHEREAS, the Authority, in furtherance of the construction of the Project, seeks to acquire certain property designated as Block 175, Lot 8 on the official tax map of the City of Camden, commonly referred to as 1 S. Broadway (the "Property"); and

WHEREAS, the Authority will require the demolition of the improvements on the Property in furtherance of the Project; and

**WHEREAS**, the demolition services will exceed the Authority's bid threshold of \$17,500.00.

**NOW THEREFORE BE IT RESOLVED**: that the Commissioners of the Parking Authority of the City of Camden authorize the Executive Director and Secretary to advertise for bids for the demolition of the Property in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

**BE IT FURTHER RESOLVED**: that the Executive Director and Secretary are hereby authorized to execute any and all related documents, including a request for proposals for the demolition of the Property.

THE PARKING AUTHORITY OF THE CITY OF CAMDEN AUTHORIZING A PAYMENT IN LIEU OF RELOCATION ASSISTANCE BENEFITS TO "V & T INC. t/a PENN PIZZA PALACE" FOR THE DISPLACEMENT AND RELOCATION OF A TENANCY IN 1 S. BROADWAY, CAMDEN, IN FURTHERANCE OF THE "BLOCK N TRANSIT VILLAGE PARKING PROJECT"

WHEREAS, the Parking Authority of the City of Camden ("Authority") is a public corporation established by declaration of necessity by the legislature in the Parking Authorities Law, N.J.S.A. 40:11A-1 et seq. for the public purpose to promote the public safety convenience welfare and the necessity in the public interest for the provision of public parking; and

WHEREAS, the Authority is vested with all powers necessary or convenient to carry out and effectuate its corporate purpose of the construction, provision or operation of off-street parking projects within its area of operation; and

WHEREAS, pursuant to the Parking Authorities Law, N.J.S.A. 40:11A-6(3) the Authority is authorized to plan, design, construct, reconstruct, enlarge, improve, manage, maintain, repair, operate and use such parking project or projects as in the opinion of the authority will provide an effective and satisfactory method for promoting the purposes of the authority; and

WHEREAS, the Authority has undertaken the planning of a mixed use development commonly referred to as the Block N Transit Village Parking Deck Project (the "Project") which includes construction of a structured parking deck and appurtenant facilities on Block 175 on the official tax map of the City of Camden; and

WHEREAS, by Resolution No. R2014-06:50 adopted on June 23, 2014, the Commissioners of the Authority resolved to authorize the planning of a mixed use development commonly referred to as the Block N Transit Village Parking Deck Project; and

WHEREAS, the Authority, in furtherance of the construction of the Project, seeks to acquire certain property designated as Block 175, Lot 8 on the official tax map of the City of Camden, commonly referred to as 1 S. Broadway (the "Property"); and

WHEREAS, V & T Inc., t/a Penn Pizza Palace ("Penn Pizza") currently occupies a ground floor space in the Property and is eligible for relocation assistance benefits; and

WHEREAS, the Authority has filed a Workable Relocation Assistance Plan with the Department of Community Affairs to identify the occupants of the Property eligible for relocation assistance benefits in accordance with New Jersey Relocation Assistance Law, N.J.S.A 52:31B-1, et seq.; the Relocation Assistance Act, N.J.S.A. 20:4-1, et seq.; and the Regulations for Provision of Relocation Assistance, N.J.A.C. 5:11-1, et seq., promulgated there under (the "Relocation Regulations"); and

WHEREAS, Penn Pizza will be required to relocate from the Property upon the Authority's acquisition of the Property; and

WHEREAS, Penn Pizza desires to relocate their business from the Property to the Project upon its completion; and

WHEREAS, the Authority has determined that it is in the best interest of the City of Camden and its residents for the Authority to enter into this Relocation Agreement with Penn Pizza for the purposes of memorializing the terms of the relocation of Penn Pizza in lieu of the relocation benefits available under the Relocation Regulations, and to set forth the principles of agreement between the Authority and Penn Pizza.

**NOW THEREFORE BE IT RESOLVED:** that the Commissioners of the Parking Authority of the City of Camden find that eligible for relocation assistance benefits in accordance with the Relocation Regulations; and

**BE IT FURTHER RESOLVED:** that the Commissioners of the Parking Authority of the City of Camden find that the timely relocation of Penn Pizza is in furtherance of the development of the Project; and

BE IT FURTHER RESOLVED: that the Executive Director and Secretary are hereby authorized to execute any and all related documents, including an agreement setting for the terms of a payment in lieu of relocation assistance benefits in the amount of \$81,500.00 and a letter of intent for new leasable space in the Project, subject to the review of counsel, to effectuate the timely relocation of Penn Pizza.
