## RESOLUTION OF

### THE PARKING AUTHORITY OF THE CITY OF CAMDEN AUTHORIZING SALARY ADJUSTMENTS FOR NON-UNION BENEFITTED EMPLOYEES IN 2021

**WHEREAS**, the Parking Authority of the City of Camden ("Authority") is a public corporation established by declaration of necessity by the legislature in the Parking Authorities Law, N.J.S.A. 40:11A-1 et seq. for the public purpose to promote the public safety convenience welfare and the necessity in the public interest for the provision of public parking; and

WHEREAS, the Authority has completed contract negotiations with the Authority's bargaining unit through 2021; and

WHEREAS, wage adjustments for the Authority's non-union benefitted employees have not been authorized by the Authority for 2021.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioner of the Parking Authority of the City of Camden as follows:

- 1. The Commissioners of the Parking Authority of the City of Camden authorize that the Authority's eligible non-union benefitted employees will receive a step-up increase in compensation of three percent (3%). Employees eligible for salary adjustment include non-union benefitted employees working at the Authority for a minimum of six (6) months as of January 1, 2021.
- 2. The salary adjustment shall be applied to eligible employees as of July 1, 2021.

**WHEREAS**, the Parking Authority of the City of Camden ("Authority") is a public corporation established by declaration of necessity by the legislature in the Parking Authorities Law, N.J.S.A. 40:11A-1 et seq.; and

WHEREAS, the Authority is vested with all powers necessary or convenient to carry out and effectuate its corporate purpose of the construction, provision or operation of off-street parking projects within its area of operation; and

**WHEREAS**, pursuant to the Parking Authorities Law, <u>N.J.S.A.</u> 40:11A-6(3) the Authority is authorized to plan, design, construct, reconstruct, enlarge, improve, manage, maintain, repair, operate and use such parking project or projects as in the opinion of the authority will provide an effective and satisfactory method for promoting the purposes of the authority; and

WHEREAS, the City Council of the City of Camden adopted Ordinance MC-5288 on October 10, 2020 amending Ordinance MC-38 relating to traffic and regulating the use of streets and highways in the City of Camden (the "Ordinance"); and

WHEREAS, the Ordinance provides for an adjustment to on-street parking meter rates; and

WHEREAS, the Authority seeks to implement a "Special Event Zone" to address parking needs in areas where "special events" may occur; and

**WHEREAS**, the "Special Event Venues" include, but are not limited to, Rutgers University, Rowan University, Waterfront Park, Aquarium, BBT Bank Center, Camden County Marina, and Battleship New Jersey; and

**WHEREAS**, a "Special Event" is any event which is held at any venue where the general public is invited to attend and a fee is charged for admission; and

**WHEREAS**, the "Special Event Zone" shall consist of on-street parking spaces regulated by time limits and/or parking fees within a 2,000 foot radius of the Special Event Venue; and

**WHEREAS,** the Authority has purchased "Smart Credit Card-Enabled Meters" that will allow for the implementation and enforcement of Special Event Zone on-street parking co-temporaneous with "Special Events"; and

**NOW, THEREFORE BE IT RESOLVED,** by the Board of Commissioners of the Parking Authority of the City of Camden that the establishment of a "Special Event Zone" consisting of on-street parking spaces regulated by time limits and/or parking fees within a 2,000 foot radius of the Special Event Venue is created consistent with City Ordinance MC-5288; and

**BE IT FURTHER RESOLVED**, that the Authority is authorized to charge a flat parking rate for a Special Event for on-street metered parking in a Special Event Zone in an amount not to exceed surface lot parking for a Special Event; and

**BE IT FURTHER RESOLVED**, that Special Event Parking fees shall be subject to City parking tax, which shall be collected by the Authority and paid to the City of Camden General Fund, parking tax fund or as otherwise directed by the City's CFO.
