Consultation Reports

Willie Hunter – Executive Director

Willie Hunter submitted a written report to the Board and noted the following status updates on PACC operations:

- With concert season approaching we will be repairing and or replacing light bulb and ballast throughout the parking lots along with repairing any other electrical malfunctions that need to be repaired through the parking lots.
- VMX our information technology (IT) company will be upgrading our sever, backup battery for the server room and replacing all the network switches.
- PACC revenue is starting to increase. We have more permit parkers in our lots as well as individuals renting lots for events.
- We have received a request from some residents in the North Camden area to have residential permit parking and will host a community meeting with residents to go over what it takes to implement the residential permit parking in that area. The permit program would be between Pearl Street and State Street and 2nd Street and 6th Street.

Joseph Myers - Camden Community Partnership

The Camden Community Partnership (formerly known as Coopers Ferry Partnership) is anticipating a busy and vibrant summer full of activities and events on the waterfront. BB&T Center is preparing for the first concert in 2 years on Saturday July 17, 2021. PACC is on track to provide all required parking for BB&T events. Lot 1 improvements paid for by a joint capital expenditure account is nearing completion.

Charles Holmes – Holmes Accounting

Mr. Holmes presented the financial report for the month of May 2021 noting a significant increase in revenue over May 2020 and a decrease in expenses.
