# <u> Willie Hunter – Executive Director</u>

Willie Hunter submitted a written report to the Board and noted the following status updates on PACC operations:

# Parking Lots Activity

- Events around the waterfront have started to pick up. The jazz concerts have been going on every other week on Monday's. On July 17<sup>th</sup> BB&T had their first concert, Wiggins Park had the Caribbean festival and Big Scott held its all white party which all brought in revenue.
- Lot 48 has a sink hole which we are working with CRA & DPW to provide a temporary fix. For everyone's safety we have blocked off the lot and put our monthly parkers on other lots.

## **Elevators**

• Elevator car one has been online since March and car two should be back online shortly. The sump pump drain line had a leak which has been fixed however a HVAC system is need in the machine room that we will need to go out to bid on. This is in your packet for approval.

# Administration

• Right now, our Enforcement Lieutenant has been on the Administration side of the office. We will be fixing up the old coin room for him and putting the coin counting machine in the old supply room. With this taking place we need to move cameras from one location to another. We are also looking to add a camera in the maintenance supply room therefore in your packet is a resolution for this.
