The City of Camden Ordinance requires that all handicap spaces in the City be accounted for and assessed an annual renewal fee. **Your 2022 renewal fee is due at this time.** Please make your check or money order payable to The Parking Authority of the City of Camden.

Type 1 sign, the renewal fee is \$20.00. Type 2 sign, the renewal fee is \$30.00.

If we do not receive your fee by February 1, 2022, we will assume the handicap sign and markings are no longer needed and we will make arrangements to have the sign and space removed.

If you would like to upgrade your Type 1 sign to a Type 2 sign there will be an additional fee of \$45 added to your annual fee.

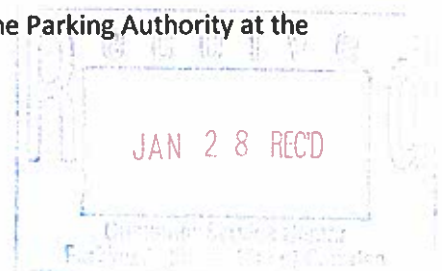
