- WHEREAS, pursuant to the information obtained by the Authority, "License Plate Recognition Technology" may be purchased through a contract awarded to Vigilant Solutions, by the National Cooperative Purchasing Alliance based on the accepted bid; and
- WHEREAS, the Authority has performed its due diligence, considered the cost savings that can be achieved through the use of cooperative purchasing from the National Cooperative Purchasing Alliance for the purchase of "License Plate Recognition Technology", and reviewed all documentation from the National Cooperative Purchasing Alliance required by law, and desires to authorize the purchase "License Plate Recognition Technology" for the Authority; and
- WHEREAS, the Authority has determined that the award of a contract to Vigilant Solutions for the purchase of "License Plate Recognition Technology" for use by the Authority in providing vital municipal services to its citizens is necessary for the continued efficient operations of the Authority; and
